

FEE SCHEDULE COMMON FEATURES



Limits and fees - The following fees may be assessed against your account and the following transaction limitations, if any, apply to your account:

Debit Card Limitations:

Consumer Debit Card: You may make no more than 25 withdrawals (Point of Sale) per day. You may withdraw no more than \$310.00 per day at ATMs (maximum of 10 transactions and resets every 24 hours). You may not exceed \$3,000.00 in pinned transactions, signature debit purchases, phone or internet purchases until processing.

Processing may take up to 72 hours.

Business Debit Card: You may make no more than 25 withdrawals (Point of Sale) per day. You may withdraw no more than \$510.00 per day at ATMs (maximum of 10 transactions and resets every 24 hours). You may not exceed \$4,000.00 in pinned transactions, signature debit purchases, phone or internet purchases until processing.

Processing may take up to 72 hours.

***CONSUMER AND BUSINESS ACCOUNT FEE SCHEDULE FOR OVERDRAFT AND RETURNED (NSF) ITEM(S)**

Definitions:

- Overdraft Fees: Items paid creating a negative balance in your account.
- Returned Item (NSF) Fees: Items not paid and returned to payee.
- Overdraft and Returned (NSF) Item Fees are based on the dollar amount of check.

Personal Accounts

For items we pay, you may be assessed an Overdraft Fee of up to \$31.00 per item. If either of the following statements is true you may be assessed a lesser fee of \$10.00 per item:

- The individual item presented for payment is less than \$50.00 or
- The resulting overdrawn balance in your account after all items are paid and before fees are assessed is less than \$50.00.



If we elect to return an item for insufficient funds (NSF), you may be assessed an NSF Fee of up to \$31.00 per item. Transactions or items include any of the following: debit card transactions, automated clearinghouse (ACH) transactions, online transfers, check transactions, our fees or charges, or other electronic transactions or withdrawals of any type. Pursuant to Nacha Operating Rules and Guidelines and other applicable laws, a debit transaction or item may be presented for payment multiple times and we do not monitor or control the number of times an item or debit transaction is presented for payment. You agree we may charge you non-sufficient funds fees for each resubmission of a debit transaction or re-presentation of an item, which means you may incur multiple non-sufficient funds fees if a debit or item is returned more than one time. For example, you write a check from your account with us. The check is returned for non-sufficient funds, and we may charge you non-sufficient funds fees. The same check is then re-presented to us for payment, and the check is returned again for non-sufficient funds. We may charge you non-sufficient funds fees the second time the check is presented for payment and returned for non-sufficient funds and each additional time it is presented for payment and returned for non-sufficient funds.

Business Accounts

For items we pay, you may be assessed an Overdraft Fee of up to \$31.00 per item. If either of the following statements is true you may be assessed a lesser fee of \$10.00 per item:

- The individual item presented for payment is less than \$200.00 or
- The resulting overdrawn balance in your account after all items are paid and before fees are assessed is less than \$200.00.

If we elect to return an item for insufficient funds (NSF), you may be assessed an NSF Fee of up to \$31.00 per item. Transactions or items include any of the following: debit card transactions, automated clearinghouse (ACH) transactions, online transfers, check transactions, our fees or charges, or other electronic transactions or withdrawals of any type. Pursuant to Nacha Operating Rules and Guidelines and other applicable laws, a debit transaction or item may be presented for payment multiple times and we do not monitor or control the number of times an item or debit transaction is presented for payment. You agree we may charge you non-sufficient funds fees for each resubmission of a debit transaction or re-presentation of an item, which means you may incur multiple non-sufficient funds fees if a debit or item is returned more than one time.
